

BATTERY/SANSOME QUICK-BUILD PROJECT

The Battery/Sansome Quick-Build Project aims to improve and provide a protected northbound and southbound bike connection to and from the Financial District. Project elements include the following on Battery Street:

- A two-way protected bikeway on Battery Street
- Travel lane reduction
- Left turn restrictions at Broadway and California Street
- Reallocating of parking and loading spaces
- Pedestrian safety improvements



Protected bikeways are not being proposed on Sansome Street, but pedestrian safety improvements such as daylighting, advanced limit lines, upgrading crosswalks and upgrading signal lens to larger size are being considered for the corridor.

Comments will be considered when a determination is made whether to implement the change. The SFMTA Board of Directors will make the final approval. Final SFMTA Decisions, whether made by the City Traffic Engineer or the SFMTA Board, can be reviewed by the Board of Supervisors. Information about the review process can be found at www.sfbos.org.

Following approval of the item by the SFMTA City Traffic Engineer, the CEQA determination is subject to appeal within the timeframe specified in S.F. Administrative Code Section 31.16, typically within 30 calendar days of the Approval Action. For information on filing a CEQA appeal, contact the Clerk of the Board of Supervisors at City Hall, 1 Dr. Carlton B. Goodlett Place, Room 244, San Francisco, CA 94102, or call (415) 554-5184. Under CEQA, in a later court challenge, a litigant may be limited to raising only those issues previously raised at a hearing on the project or in written correspondence delivered to the Board of Supervisors or other City board, commission or department at, or prior to, such hearing, or as part of the appeal hearing process on the CEQA decision.
